We, **KIRTI SHARMA & ASSOCIATES**, Practicing Company Secretaries, have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **M/s. CINERAD COMMUNICATIONS LIMITED** ('the listed entity'), having its Registered Office at **Subol Dutt Building, 13, Brabourne Road, Mezzanine Floor, Kolkata - 700001**. Secretarial Review was conducted in a manner that provided us a reasonable basis for evaluating the corporate conducts/statutory compliances and expressing our opinion thereon.

Based on our verification of the listed entity's books, papers, minutes books, forms and returns filed and other records maintained by the listed entity and also the information provided by the listed entity, its officers, agents and authorized representatives during the conduct of Secretarial Review, we hereby report that in our opinion, the listed entity has, during the review period covering the financial year ended on March 31, 2024, complied with the statutory provisions listed hereunder and also that the listed entity has proper Board processes and compliance mechanism in place to the extent, in the manner and subject to the reporting made hereinafter:

We, **KIRTI SHARMA & ASSOCIATES**, Practicing Company Secretaries, have examined:.

- (a) all the documents and records made available to us and explanation provided by the **Listed Entity**,

The Board of Directors of the Company in its meeting dated 13th March, 2024 allotted

- 28,00,000 equity shares of Rs.10/- each at a price of Rs. 10/- to non-promoters on a preferential basis for cash consideration and;
- 1,11,61,915 equity shares of Rs.10/- each at a price of Rs. 10/- to promoters on a preferential basis for non-cash consideration pursuant to share swap.

The paid-up Capital after allotment was 1,91,61,915 equity shares of Rs. 10/- each.

During the year, there has been a change in the control and management of the Company pursuant to transfer of shares from existing promoters to new promoters as well as the allotment of new equity shares through preferential issue under the provisions of Companies Act, 2013 and the SEBI ICDR Regulations. Subsequent to acquisition of shares and control by the new promoters, the requirement to make an open offer was triggered under the provisions of SEBI Takeover Regulations and SEBI Listing Regulations and the Company has taken the necessary steps as may be required to do so under the applicable laws.
